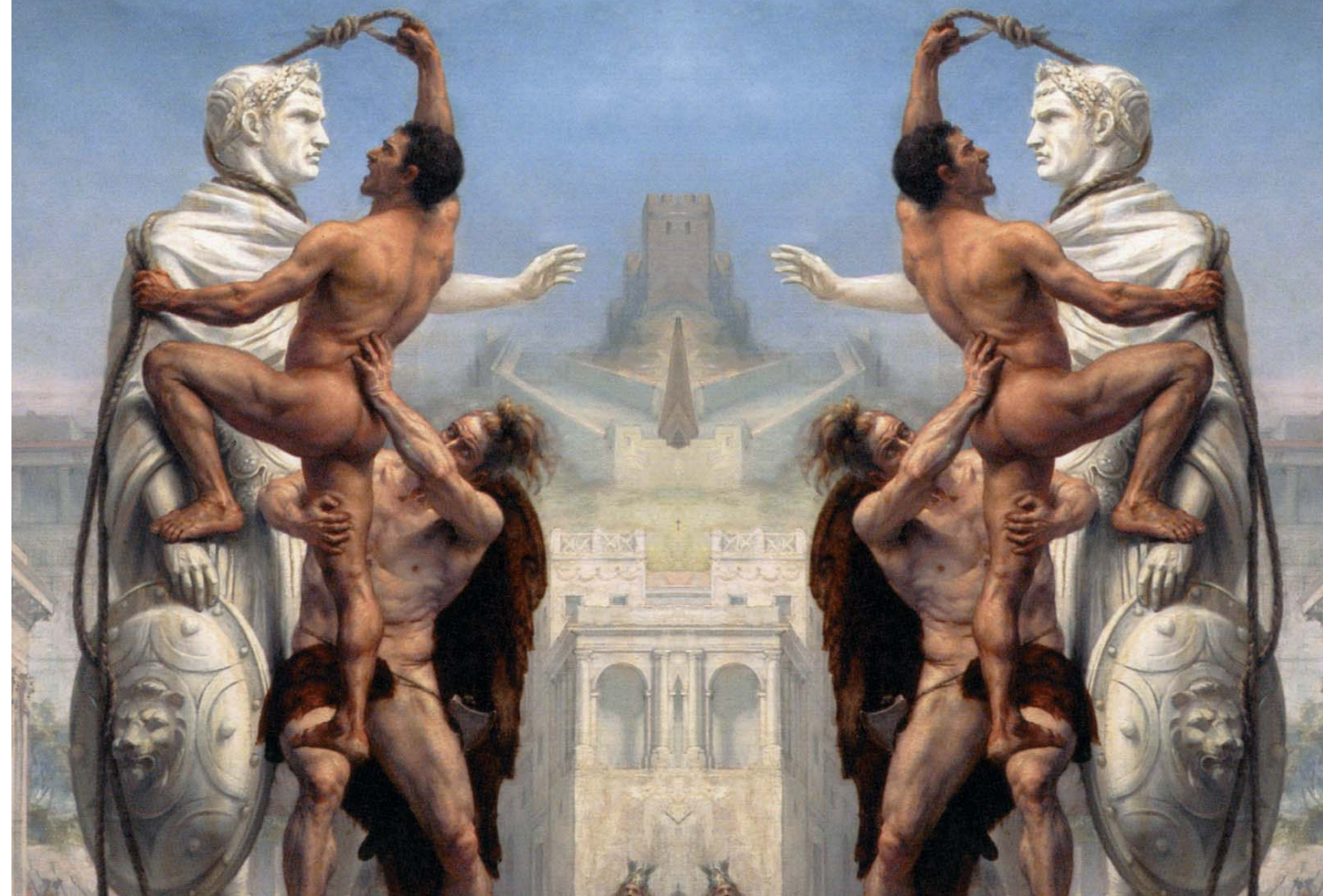

## 410 AD THE SACK OF ROME

24 August 2010 marks the date of the 1600th anniversary of the sack of Rome by the West Gothic king Alaric and his troops. The capture of the caput mundi marked a caesura in the history of the Eternal City. It was seen by pagans and Christians alike as a global event, found various echoes in contemporary literature and was perceived and commented upon far beyond Rome itself. The anniversary of this 'global event' shall be taken as an occasion to analyse the construction of the sack of Rome from different disciplines, to analyse the range of meanings of the year 410 both in history and in its reception, and to investigate the city of Rome as a symbol of collapse and renewal. The latter issue is less concerned with the verification of historical facts, but focusses rather on the uncovering of multiple facets and dissonances of the concept of a city's fall and (eventual) resurrection.

For this reason, in autumn 2010 two research conferences in Rome are dedicated to the theme of Alaric's sack of Rome in 410. From 7 to 9 October, the **Istituto Svizzero di Roma** has organised the conference *'The Fall of Rome in 410 and the Resurrections of the Eternal City,'* in which the questions of representation and depiction of the event and its reception will be considered primarily from a historical and literary-philological perspective. A complementary event is being held under the aegis of the **German Archaeological Institute at Rome** from 4 to 6 November, in a conference entitled *'410 – The Sack of Rome: the Fall, its Context and its Impact.'* This conference primarily gathers the archaeological data for the sack of Rome in 410 and discusses the context of what led up to the event and the historical consequences thereafter. Two contributions which consider the event from the perspective of its meaning for the end of the Roman Empire round off and close the conference.

The joint opening of both conferences takes place on the evening of 7 October in the presence of prominent invited guests at the **British School at Rome**.
